PROVIDENCE NEIGHBORHOOD ASSOCIATION MEETING HOUSE POOL RULES & REGULATIONS



(Subject to change without further notification)

These Pool Rules and Regulations are part of the Providence Neighborhood association's continuing effort to provide a safe recreational environment. Please review these rules before visiting the Meeting House swimming pools. Those who wish to use the Meeting House swimming pools must first read and sign the **Providence Neighborhood Association Waiver of Liability and Permission Form**.

Violations of pool rules may result in loss of pool privileges. If you have questions about any of these rules, please contact the Meeting House manager on duty. These rules and regulations are provided to all eligible persons who are members of The Village of Providence Neighborhood Association and who are registering for pool usage memberships and swim cards. Rules will also be posted at the pool.

General - The following rules apply to all areas of the Meeting House pool

- **❖** No person may use the pool unless it is officially open.
- ❖ NO LIFEGUARD WILL BE ON DUTY AT THE MEETING HOUSE POOL. SWIM AT YOUR OWN RISK.
- Lach resident must obtain a membership proximity ID card for admission to the Meeting House pool.
- ❖ Membership ID cards are available in the Providence Properties Office at 7 Town Center Drive, Suite 102 and will be issued approximately seven (7) working days from the date the Waiver of Liability and Permission Form is received.
- The membership proximity ID cards must be swiped by pool patrons each time they enter the pool complex.
- Guests are limited to four persons per household and must be accompanied by a resident. The resident will be assessed a daily usage fee by the association for each guest over four persons.
- Each resident is responsible for their behavior and that of their guests. The resident's privileges may be revoked if their behavior or any guest's behavior is deemed inappropriate, or if any rules of the Meeting House or Providence are broken.
- ❖ Each resident is responsible and will be assessed for any damage that may occur at the Meeting House or Pool area. This includes any damage caused by the guest of any resident.
- All children must be accompanied and supervised by an adult at all times.
- ❖ Infants are allowed only in the kiddie pool and are required to wear plastic pants or swim diapers.
- ❖ Any patron in water deeper than the patron's armpits may be required to demonstrate to the Meeting House Manager or other personnel designated by the Association that he or she is capable of swimming the width of the pool in that depth. If the patron is unable to do so, he or she must remain in water that is below his or her armpits.
- Only swimming apparel may be worn in the pool. Clean white T-shirts are allowed when worn over swimming apparel. Cut-off shorts, walking shorts, bicycle shorts and athletic shorts are not to be worn in the pool.
- Admission to the pool will be refused to all persons having skin disease, sore or inflamed eyes, colds, nasal or ear discharge, or any communicable diseases.
- The following items or activities are prohibited at the Meeting House pool:
 - a. Diving from pool sides.
 - b. Glass containers.
 - c. Radios, CD players, TV's, and tape recorders (unless used with personal headphones).
 - d. Animals, other than mobility guides for the disabled.
 - e. Any other item or activity that creates a hazard to patrons or to the maintenance and operation of the Meeting House pool.
 - f. Persons wishing to take pictures inside the pool area must obtain permission from the Meeting House manager.

The Providence Neighborhood Association and the Town Founder have the authority to enforce these rules and may remove from the Meeting House pool area any patron who violates these rules.		

MEETING HOUSE POOL RULES & REGULATIONS (Cont')

Personal Property

The Village of Providence, the Providence Neighborhood Association, and Slyman Construction Company, its affiliates, owners, employees, agents, heirs, or independent contractors assume no liability for the loss or theft of a patron's personal belongings.

Pool Closings

The Pool Manager or other designated personnel may close the entire pool complex, or any portions of the pool complex, for any safety or maintenance reason.

Kiddie Pool

The Kiddie Pool is for use by patrons six years of age and under. A responsible party, who is always within arm's reach of the child, must supervise such patrons.

Jr. Olympic Pool Lap Lanes

Lap Lanes may be reserved from time to time by the association for lap swimming, organized fitness programs, and scheduled lessons.

Diving

Any patron wishing to use the diving boards must adhere to the following rules:

- a. Divers using the diving board must be at least 48 inches tall or supervised by the responsible party.
- b. Divers must wait for the person ahead of them to reach the pool ladder prior to diving off the board.
- c. Divers may not do sit-drop or inward dives.
- d. Divers may only make one approach and one bounce per dive.
- e. Divers may not wear eyewear or goggles when diving.

Modifications for Persons with Disabilities

The Providence Neighborhood Association will make reasonable modifications to the Pool Rules and Regulations for any person with a qualified disability. Any person requesting modifications to these rules and regulations must identify the qualified individual with a disability and request the modification in writing to the Providence Neighborhood Association.
